

TORRANCE WOMAN'S CLUB – BOARD MEETING
March 31, 2010

President Deanna Hanson called the Board Meeting of the Torrance Woman's Club to order on March 31st, 2010 at 10:00 a.m. Members were welcomed. There were no guests.

First Vice President Barbara Freeman reported that there were eight TWC members at the District meeting on March, 19th. TWC had the following winners in the Arts and Crafts contest: Joanne Free, Kathleen Davis, and Pat Brinton won 2 ribbons, including "Best of Show". There were 4 winners in the Children's category: Best of Show was Caroline Martin's son. Three other awards were 2nd, 3rd, and Honorable Mention. The Marina District Convention will be held April 17th, at the Marina Del Rey Marriott Hotel.

Second Vice President Beverly Greeno thanked the 39 ladies who contributed food to the Toyota Museum event. Beverly reported that there will be a new member introduced at the April meeting. Her name is Evelyn Engel—16th new member this year. Total membership is 151.

Third Vice President Fran Day reported that the roofing project is finished. She reported that the floors need waxing and buffing.
